Update on annual reports for Joint degrees

Academic Standards Committee's remit includes receipt of annual reports for degrees which the University awards jointly with other institutions.

It was agreed previously that all annual reports received should be submitted to ASC, and that for the degrees where Glasgow was the lead institution, each report should be considered in detail by two nominated ASC reviewers, similar to the model used for considering DPTLA/PSR reports.

<u>Appendix 1</u> presents the ASC reviewers allocated to each report for degrees administered by the University of Glasgow.

ASC also agreed the following process:

Annual Monitoring Reports to be presented to the Joint Programme Boards. A report from the Joint Board, including matters of the Annual Monitoring Reports and other important aspects (such as major changes to the programme, operational issues and review of programmes) is then submitted to the Academic Standards Committee annually in November.

Senate Office requested reports from the Joint Management Board for the Joint programmes from the relevant Colleges in order to forward these to ASC. These have been received with various success. An up to date list of the joint degrees is provided in the tables below along with the report status update. Specific Joint Management Board reports are appended.

ASC is asked to reconsider the most optimal timing for submission of future reports given that many of the reports were dated post November.
