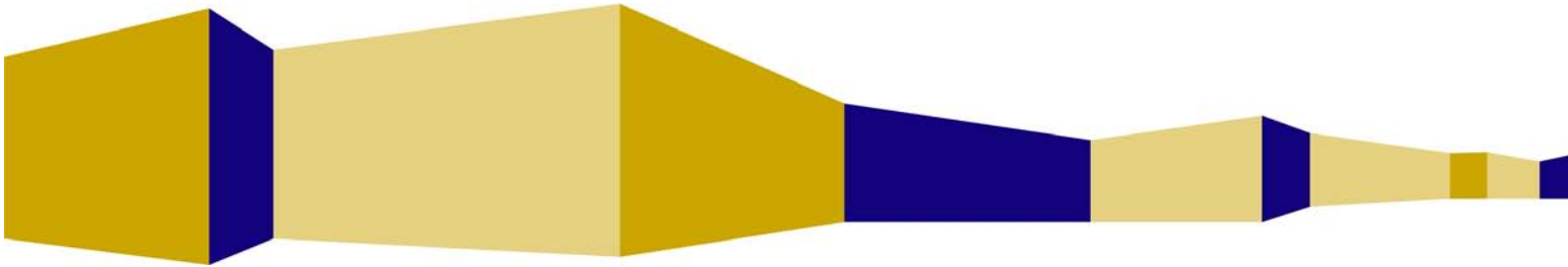

**Consideration**

The Convenor welcomed the panel and programme team and outlined the schedule of the meeting.

The Programme Proposer introduced the programme and outlined the rationale, following which the External Critical Friend confirmed that the aims of the programme were robust and had been well considered with a focus on peer integration and independent learning. The External Critical Friend also confirmed previous comments offered at Stage 1, including the scope of the Learning Outcomes of the programme, had now been addressed.

The representatives from University of Glasgow confirmed that the aims and intellectual content of the programme were robust.

Following a helpful discussion with the Programme Proposer and Convenor of the Undergraduate Non-School Board of Studies the Panel agreed to recommend that Academic Council approve the validation of the International Foundation, subject to the following conditions and recommendations:

**Programme Conditions, Recommendations and Commendations/Notes**

**Conditions**

1. The programme documentation must set out clear requirements regarding English Language entrance qualifications appropriate to the level of entry. The Panel noted that several factors, including recruitment pool, UKBA requirements and academic progression, would be considered when defining this.
2. The programme documentation must clarify the position regarding exemption from, and substitution of, prescribed courses. Should exemptions and substitutions be available, these must be appropriately detailed in the documentation.

3. Given that students may progress to Year 1 of an undergraduate degree the issue of duplication of courses should be addressed in the programme documentation.

*[Secretary's Note: Further conditions set at Academic Council have superseded this condition]*

4. Programme Regulations must be addressed to the satisfaction of Academic Services.
5. Technical issues (see appendix 1) in the programme documentation must be addressed. Academic Services has detailed these issues in a separate note to the Programme Proposer and Board of Studies Convenor.

### **Recommendations**

1. The Programme Proposer should consider how this programme can apply APL/APEL to applicants prior to the programme commencing. The Panel noted that GSA was currently considering the institutional APL/APEL policy.

### **Commendations**

1. The Convenor commended the documentation on the academic aims of the programme and reiterated the positive feedback from both the External Critical Friend and University of Glasgow representatives.

The following issues must be addressed as stated in the conditions of the approval of the International Foundation programme:

Covering Note

1. All relevant additional information (including oral updates) must be incorporated into the programme documentation.
2. The proposed suitability of External Examiners should be reconsidered and approval will follow the GSA External Examiner nomination process.

Programme Information Document

1. Section A4 (p2) confirms that there are no substantive changes from the Statement of Intent. As progression is a substantive change the PID must reflect this.
2. Section A12 (p4) regarding Equity and Diversity should be revisited and enhanced.
3. Section A18 (p5) describing Professional Development opportunities requires further information.
4. Section A19. Knowledge and Exchange must be addressed in the context of Institutional Priorities.

External Critical Friend Consultation Pro Forma

1. A response to the External Critical Friend feedback must be included.

Employer/Industry Consultation Pro Forma

1. The choice of current employer/industry friend is not appropriate and should be reconsidered.

Programme Specification

1. Section 1. regarding Max/Min duration is not correct and should be amended.
2. Section 16. is missing specific details such as weighting and term of study and must be included as this is essential for the GSA HESA return.
3. Section 20. regarding internal transfers requires further detail.
4. Section 24. is out of date and insufficient. This must be addressed and updated.
5. The detail in section 25a. regarding Quality Assurance insufficient.

The Programme Proposer confirmed that an additional External Critical Friend was intending to be present but unfortunately, owing to unforeseen circumstances, was unable to attend. Written feedback from the External Critical Friend was due to be provided to the Programme Proposer and forwarded to Convenor and Academic Services when available. The Programme Proposer also confirmed that feedback from the External Critical Friend had been received at Stage 1 of the programme approval process and had been acted upon.

The Programme Proposer introduced the programme and outlined the rationale for creating a suite of Masters programmes, following which the representatives from University of Glasgow confirmed that the scope of the programmes was positive as it builds on the specialist nature and reputation of current programmes at GSA.

Following a helpful discussion with the Programme Proposer and Head of the School of Design the Panel agreed to recommend that Academic Council approve the validation of the International Foundation, subject to the following conditions and recommendations:

1. Programme Regulations must be addressed to the satisfaction of Academic Services.

1. The Programme Information Document should be rephrased in terms of entire suite of awards rather than focusing primarily on Design Innovation and Citizenship.

1. Section 1. Should included maximum duration of study
2. Sections 17/18/19/20/21 (exemptions/APEL/advanced entry/transfer) must be included.

**Consideration**

The Head of Academic and Student Services confirmed that, following the Academic Standards Committee recommendation that a member from the School of Education be included on the panel, Academic Services and the Senate Office been sought to include suitable representation but unfortunately this had not been possible. However, the Head of Academic and Student Services highlighted that the appointed External Critical Friend was from the School of Education and that two representatives from the University of Glasgow were also on the panel.

The Programme Proposer introduced the programme and outlined the rationale for amalgamating and extending the current Postgraduate Certificate programmes.

The Student Representative confirmed that the proposed programme was well considered and as Stage 1 and 2 focus on both aspects of teaching Stage 3 allows for reflection which was very positive. The Student Representative did highlight that the anticipated workload seemed substantial but felt that as the programme is predominately aimed for internal GSA staff the aims of the programme should be high and thorough.

The Panel confirmed that it should recommend to Academic Council that the programme could exceptionally not include the Core Research Skills course which is a prerequisite for all GSA postgraduate taught programmes.

Following a helpful discussion with the Programme Proposer and Head of the School of Design the Panel agreed to recommend that Academic Council approve the validation of the International Foundation, subject to the following conditions and recommendations:
