Periodic Subject Review: Update in Respect of Recommendation 6 Arising from the Review of Law held on 20 and 21 February 2018: Enhanced EvaSys Procedures and Student Response Rates

I was asked to report to the ASC about the enhanced EvaSys procedures I put into effect for administering student questionnaires in the law school, 2018/19. By comparing data from 2017/18, we can see a significant increase in our student response rate. By further comparing data for the six courses which did not participate in the exercise, we can confidently attribute the improvement in response rate to the enhanced procedures.

Takeaways

The table below shows the improvement in the response rate, divided by undergraduate level. The full data is attached as an Appendix to this memo.

Explanation of comparison

I prepared the enhanced procedures after our PSR in 2017/18, and put them into effect in the autumn of 2018. Compliance was high but not perfect. There were no reported problems in implementation. An unknown number of postgraduate courses also used the enhanced procedures, and most PG courses did show improvement, but we do not know what methods each course used, and so could not include PG courses in the table.

As the table (and the full data in the Appendix) shows, courses that used the enhanced procedures showed a much higher student response rate. Every course showed improvement, and courses which did not use the procedures showed far less improvement, and in one case, regression.

Enhanced procedures

The enhanced procedures are below, set out as guidance for policy documents.

- Course convenors shall select a survey day at the beginning of the course and announce it via Moodle. The recommended survey day is usually the final meeting of students, whether lecture or seminar, but any other day near to the end of teaching is acceptable.
- 2. The day before the survey day, course convenors shall make an announcement via Moodle.
- 3. The relevant QA Administrator shall configure EvaSys to send an email to the students on the morning of the survey day, with a link to the survey.
- 4. At the class meeting at which the survey is conducted, the course convenor shall direct students to their inboxes to locate the survey link, and allow students 5–10 minutes at the beginning of the session to complete the survey.
- 5. Reminders shall be sent to non-completing students on the following day.
- 6. Surveys shall remain open for two weeks after the end of teaching.

These procedures are used alongside other recommendations by Senate, e.g. the recommendation that emails be personalised to the course and convenor.
